2. The Types of Personal Data We Collect

Identity Data – name, username, title

Contact Data – email, phone, postal address

Technical Data – IP address, device information, operating system, browser data, time zone

Usage Data – pages viewed, clicks, scrolling behaviour, session duration

Profile Data – saved preferences, quiz or content usage history

Marketing Data – email preferences

Aggregated Data – statistical data that does not identify you

Emails you send to us are stored within Gmail, which may process data internationally.

No Special Category Data is collected.

3. How Your Personal Data Is Collected

A. Direct Interactions

You provide data when you:

- submit a form
- subscribe to newsletters
- create an account
- complete quizzes or surveys
- contact us by email (stored in Gmail)

B. Automated Technologies

Wix.com automatically collects Technical and Usage Data using:

- cookies
- beacons

- server logs
- device fingerprinting
- behavioural analytics

C. Third-Party Sources

We may receive data from:

- Wix.com (hosting, analytics, security, forms, members area)
- Google Analytics (if enabled)
- Wix email marketing tools
- Payment processors (e.g., Wix Payments, Stripe)
- Google Gmail (email content you send us)

4. Full Wix.com Data Flow Explanation

Because the Website is built using Wix, Wix processes data in the following ways:

Website Hosting

Wix hosts the Website, including:

- site content
- user-submitted forms
- account and login data
- interaction history
- analytics events

Wix Analytics

Wix collects anonymised and pseudonymised usage data including:

- pages visited
- links clicked
- IP address
- device and browser information
- geographic region (approximate)
- time spent on site
- session heatmaps

Forms and User Inputs

When you complete contact forms, quiz submissions or other inputs:

- data is stored on Wix servers
- data may be emailed to us and therefore stored in Gmail
- Wix may also hold backups for security and operational continuity

Members Area (if used)

If the Website later includes a login/member portal, Wix stores:

- usernames
- encrypted passwords
- profile details
- activity logs

Payment Processing (if used in future)

Wix Payments or Stripe may collect:

- payment card details
- transaction identifiers

- billing information
- fraud prevention metadata

Wix Security

Wix processes:

- IP address
- behavioural patterns
- suspected malicious activity
- access logs

to detect fraud and ensure platform security.

Wix Cookies

Wix places essential and analytics cookies. These may include:

- session cookies
- security cookies
- performance cookies
- visitor analytics cookies

- regulators where legally required

Third-party processors must safeguard your data.

7. International Transfers

Because Wix and Gmail operate globally, your data may be transferred to:

- United States
- Israel
- European Union
- other permitted jurisdictions

Transfers rely on:

- Standard Contractual Clauses (SCCs)
- adequacy decisions
- other lawful safeguards

By using the Website, you acknowledge international transfers may occur.

8. Data Security

Wix and Gmail implement:

We notify users and regulators of any notifiable breaches.

9. Data Retention

We keep personal data only as long as necessary.
